Pursuant to article 6 para. 3 Commission Delegated Regulation (EU) 2016/958 of 9 March 2016 and any further applicable rules in case of distribution through its affiliates, MainFirst has to disclose relationships and circumstances that may create conflicts of interest because they could impair the impartiality of the producer(s), MainFirst including its affiliates or any other persons or entities that are acting on their behalf and are involved in the production of this Publication. MainFirst updates this list of companies quarterly. MainFirst evaluates the estimates of the research reports in relation to the services rendered for the companies through the Investment Banking division.

If any, the relations to the companies analysed are disclosed in all financial research by using the following keys:

- (1) hold shares exceeding 1% of the total issued share capital of the subject issuer or the subject securities or other financial instruments (the “Company” or the “Companies”) calculated under computational methods required by German law (data as of the last trading day of the past month)
- (2) act as a market maker or liquidity provider in the financial instruments of the Company
- (3) belong to a consortium as a lead manager or co-lead manager of any publicly disclosed offer of financial instruments of the Company over the previous twelve (12) months
- (4) form party to any other agreement with the Company relating to the provision of investment banking services that has been in effect over the previous twelve (12) months or has given rise during the same period to the payment of a compensation or expects to receive or intends to seek compensation for investment banking services from the Company in the next three (3) months.
- (5) form party to an agreement with the Company relating to the production of the Publication or any recommendation (this includes agreements concerning the production of commissioned research)
- (6) act as a corporate broker to the Company
- (7) have a material conflict of interest at the time of distribution of the Publication or any other significant financial interest in relation to the Company
- (8) have received non-investment banking related compensation from the Company within the past year
